## Emission Testing Required in 2025

**Model years 2001-2022 must have a passing emission test to register or renew in 2025.**

### What If My Vehicle Does Not Pass the Emission Test?

It's wise to get your vehicle inspected four to six weeks before your registration renewal date. This will allow you to have sufficient time to address any unforeseen issues that might arise with your vehicle. However, even when done early, your vehicle might fail an emission test. If that happens, follow these steps to get your vehicle repaired and retested.

- Check for warranties, recalls, and technical service bulletins regarding the emission control system for your vehicle. This could save you time and money.
- Get a diagnostic performed on the vehicle to determine what emission repairs are needed.
- Have the vehicle repaired. Go to the *RepairWatch Public Report*, available at [Cleanairforce.com/common/repairwatch](https://CleanAirForce.com/common/repairwatch) for a list of repair facilities.
- Ask the mechanic to complete the Emissions Repair Form after the repairs are finished.
- Take the completed Emission Repair Form back to the inspection station you used for a free retest (within 30 days of the original test date).



Understanding this process will give you the confidence to resolve a failed emission inspection and get safely back on the road. Visit [CleanAirForce.com](https://CleanAirForce.com) for testing locations and other emission information.

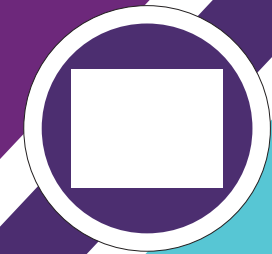

# GET YOUR DECAL INSTANTLY AT A KIOSK



Kiosks are a convenient way to renew your tag. All you need is your driver's license and debit or credit card to get your decal instantly. Convenience fees apply and one fee covers up to 10 vehicles. You can renew your vehicle up to 60 days before your birthday. Kiosks are located across the county and metro area. Many are located in Kroger and Publix stores. ## RENEW YOUR TAG WITHOUT EVER LEAVING YOUR VEHICLE

Did you know that two of our locations offer drive-thru services? At the tag offices in **Lawrenceville (750 S. Perry St.)** and **Snellville (2845 Lenora Church Rd.)**, you can renew your tag and receive or renew a disabled person's placard without having to leave your car.

When renewing at a drive-thru you can renew up to three tags in a single transaction and can pay using a credit card, check, cash, or money order.

Disabled person's placard applications can be picked up in the drive-thru, and the placard can be issued as long as the completed application is submitted. You can also download the application from our website or pick up one in any tag office.

*Please note: Title work cannot be processed in a drive-thru and property tax payments are only accepted inside.*
